### **Notice to Exhibitors**

**The ISWS, its officers and directors and the Silkenfest Committee will not be responsible for dogs or personal property**, nor do they assume responsibility for a wrong entry.

Entries: Exhibitors are advised to print all unusual words when filling out entry forms. Entries will be put in the catalogue EXACTLY as they are listed on the entry forms. Owners are responsible for errors in the entry forms. No dog wrongly entered in a class may be transferred to another class after close of entries. No entry may be changed or canceled unless notice of the change or cancellation is received in writing or via email by the Show Secretary as listed in this premium. Entries will not be accepted without the proper signature and fees. Entries must be submitted on approved entry forms, unless they are approved by the Show Secretary as listed in this premium. **No entry fee will be refunded** in the event a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of any member if the ISWS Board, the Show or Meet Secretary, or any member of the Silkenfest Committee. No entry fees will be returned if the show cannot open or be completed by reasons beyond the control of the management. Extreme weather conditions, such as, but not limited to, snow storms, hurricanes, lightning, extreme heat or cold, must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitor and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry fees will be made.

**Declination of Entries:** The International Silken Windhound Society and the Silkenfest Show Committee reserve the right to decline or remove any dog due to disease, viciousness, or other cause and no one shall have any claim against the aforementioned club, committee, or any official thereof. No refund of any entry fees will be made.

**Exhibitor Responsibilities:** All dogs present must be held on leash or confined to their crates while on the premises. It is expressly understood that the exhibitors alone are responsible for the behavior of their dogs and/or children. Each Owner and Agent listed on the entry form and/or individual responsible for the dog at a show is bound by the <u>Agreement</u> below as well as the <u>policies Purina Farms</u> has set forth for the use of their facilities and found on <u>page 5</u> of this premium regardless of who may have completed and submitted the entry form. The Club, Show Secretary, their Agents, and Employees assume no responsibility for injury to dogs or attendees. The ISWS, its officers and directors and the Silkenfest Committee will not be responsible for any loss, damage or injury sustained by exhibitors, handlers, attendees' dogs or property.

**Judges will not wait** for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the ring when their classes are called to be judged.

**No Smoking** under any show tent. Crates are not allowed under judging tents, nor or spectators, attendees, or photographers. Please remember to turn off cell phones and/or pagers before entering the ring.

### **Agreement**

I/we agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I/we agree to hold the ISWS, their members, directors, governors, officers, agents, superintendents, event secretaries and committee members, as well as the owner/lessee of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, including judges, secretaries, and stewards, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I/we personally assume all responsibility and liability for any such claim; I/we further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I/we hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death, at any time resulting therefrom, sustained by any person or persons, including myself/ourselves, or on account of damage to property, arising out of or in consequence of my/our participation in this event, however such injuries, death or property damage may be caused, and whether or not the same parties or any of their employees, agents, or any other persons. **I/we agree that any cause of action, controversy or claim arising out of or related to the entry, exhibition or attendance at the event between the ISWS and the Silkenfest Committee, and myself/ourselves or as to the construction, interpretation and effect of this agreement shall be settled by arbitration pursuant to the applicable rules of the American Arbitration Association.**

### Parking

Parking is permitted on black top and gravel lots. During large events, grassy areas may be authorized for parking and will either be marked or someone from the host club will direct guests to an authorized area.

### **Canopies and Tents**

Canopies and tents are permitted on and around parking areas outside the fenced-in show field. Canopies can also be set up on gravel areas inside the show area. During large events, we ask that exhibitors be considerate of others and use only the minimal space they require. Please no tenting or exercise pens on the show fields.

### Crating

Crating is allowed ringside 15 minutes prior and 15 minutes after the scheduled class in which handlers and their dogs are competing. Exercise pens are allowed on all parking areas. Grassy areas outside the show field can also be used.

### Vendors

Venders should check-in with the organizing club when they arrive on the grounds. At that time, venders will be given directions on set-up and parking.

### Waste

Containers are placed throughout the grounds. White barrels are for paper trash and brown barrels are for pet waste. Complimentary plastic gloves are provided for your convenience at these locations. There is also designated relief areas set up for dogs to use. PLEASE PICK UP AFTER YOUR PET.

### **Show Field**


The show field is designated as all grassy areas inside the green fence.

#### **Methods of Examination**

#### **Clinical Examination**

- 1. The clinical cardiac examination should be conducted in a systematic manner. The arterial and venous pulses, mucous membranes, and precordium should be evaluated. Heart rate should be obtained. The clinical examination should be performed by an individual with advanced training in cardiac diagnosis. Board certification by the American College of Veterinary Internal Medicine, Specialty of Cardiology is considered by the American Veterinary Medical Association as the benchmark of clinical proficiency for veterinarians in clinical cardiology, and examination by a Diplomate of this specialty board is recommended. Other veterinarians may be able to perform these examinations, provided they have received advanced training in the subspecialty of congenital heart disease.
- 2. Cardiac auscultation should be performed in a quiet, distraction-free environment. The animal should be standing and restrained, but sedative drugs should be avoided. Panting must be controlled, and if necessary, the dog should be given time to rest and acclimate to the environment. The clinician should be able to identify the cardiac valve areas for auscultation. The examiner should gradually move the stethoscope across all valve areas and also should auscultate over the subaortic area, ascending aorta, pulmonary artery, and the left craniodorsal cardiac base. Following examination of the left precordium, the right precordium should be examined.
  - The mitral valve area is located over and immediately dorsal to the palpable left apical impulse and is identified by palpation with the tips of the fingers. The stethoscope is then placed over the mitral area and the heart sounds identified.
  - The aortic valve area is dorsal and 1 or 2 intercostal spaces cranial to the left apical impulse. The second heart sound will become most intense when the stethoscope is centered over the aortic valve area. Murmurs originating from or radiating to the subaortic area of auscultation are evident immediately caudoventral to the aortic valve area. Murmurs originating from or radiating into the ascending aorta will be evident craniodorsal to the aortic valve and may also project to the right cranial thorax and to the carotid arteries in the neck.
  - The pulmonic valve area is ventral and the one intercostal space cranial to the aortic valve area. Murmurs originating from or radiating into the main pulmonary artery will be evident dorsal to the pulmonic valve over the left hemithorax.
  - The tricuspid valve area is a relatively large area located on the right hemithorax, opposite and slightly cranial to the mitral valve area.
  - The clinician should also auscultate along the ventral right precordium (right sternal border) and over the right craniodorsal cardiac border.
  - Any cardiac murmurs or abnormal sounds should be noted. Murmurs should be described as indicated below.

# 3. Description of cardiac murmurs—A full description of the cardiac murmur should be made and recorded in the medical record.

- Murmurs should be designated as systolic, diastolic, or continuous.
- The point of maximal murmur intensity should be indicated as described above. When a precordial thrill is palpable, the murmur will generally be most intense over this vibration.
- Murmurs that are only detected intermittently or are variable should be so indicated.
- The radiation of the murmur should be indicated.
- Grading of heart murmurs is as follows:
  - Grade 1—a very soft murmur only detected after very careful auscultation
  - Grade 2—a soft murmur that is readily evident
  - Grade 3—a moderately intense murmur not associated with a palpable precordial thrill (vibration)
  - Grade 4—a loud murmur; a palpable precordial thrill is not present or is intermittent
  - Grade 5—a loud cardiac murmur associated with a palpable precordial thrill and audible even when the stethoscope is lived from the thoracic wall
  - Grade 6—a loud cardiac murmur associated with a palpable precordial thrill and audible even when the stethoscope is lifted from the thoracic wall
- Other descriptive terms may be indicated at the discretion of the examiner; these include such timing descriptors as: proto(early)-systolic, ejection or crescendo-decrescendo, holo-systolic or pan-systolic, decrescendo, and tele(late)systolic and descriptions of subjective characteristics such as: musical, vibratory, harsh, and machinery.

#### 4. Effects of heart rate, heart rhythm, and exercise.

- Some heart murmurs become evident or louder with changes in autonomic activity, heart rate, or cardiac cycle length. Such changes may be induced by exercise or other stresses. The importance of evaluating heart murmurs after exercise is currently unresolved. It appears that some dogs with congenital subaortic stenosis or with dynamic outflow tract obstruction may have murmurs that only become evident with increased sympathetic activity or after prolonged cardiac filling periods during marked sinus arrhythmia. It also should be noted that some normal, innocent heart murmurs may increase in intensity after exercise. Furthermore, panting artifact may be a problem after exercise.
- It is most likely that examining dogs after exercise will result in increased sensitivity to diagnosis of soft murmurs but probably decreased specificity as well. Auscultation of the heart following exercise is at the discretion of the examining veterinarian.
- At this time the OFA does not require a post exercise examination in the assessment of heart murmurs in dogs; however, this practice may be modified should definitive information become available.

### **Canine Good Citizen (CGC) Exercises**

#### 1. Meeting and accepting a friendly stranger:

This test demonstrates that your dog will allow a friendly stranger to approach it and speak to you in a natural, everyday situation. The evaluator will walk up to your dog and you and greet you in a friendly manner, ignoring your dog. The evaluator and you will shake hands and exchange pleasantries. Your dog must show no sign of resentment or shyness, and must not break position or try to go to the evaluator.

#### How to practice:

Take your dog out and about with you. Many pet stores allow dogs to accompany you while you shop. Home Depot allows "dogs in training" to accompany you while browsing through the store. Or, when you are out for a walk – greet passer bys with a "hello." Treat your dog as he passes them calmly and waits while you exchange pleasantries with the other person. Take your dog to visit the vet – EVEN when he doesn't need a check up! Sign you dog up for an obedience class. What better way to get you dog WELL socialized but in a controlled setting!

#### 2. Sitting politely for petting:

This test demonstrates that your dog will allow a friendly stranger to touch it while it is out with you. With the dog sitting at your side, to begin the exercise, the evaluator pets your dog on the head and body. You may talk to your dog throughout the exercise. Your dog may stand in place as it is petted. Your dog must not show shyness or resentment.

#### How to practice:

When meeting passer bys, have your dog sit to be greeted. Use a happy voice and lots of treats. If your dog starts to jump or be rambunctious – turn your back and walk away from the greeter – then turn around and try it again. Patience, patience, patience. Your dog must meet people on YOUR terms.

#### 3. Appearance and Grooming:

This practical test demonstrates that your dog will welcome being groomed and examined and will permit someone, such as a veterinarian, groomer or friend of yours, to do so. It also demonstrates your care, concern, and sense of responsibility for your pet. The evaluator inspects your dog to determine if it is clean and groomed. Your do must appear to be in a healthy condition (i.e., proper weight, clean, healthy and alert). You should supply the comb or brush commonly used on your dog. The evaluator then softly combs or brushes your dog, and in a natural manner, lightly examines the ears and gently picks up each front foot. It is not necessary for the dog to hold a specific position during the examination, and you may talk to your dog, praise it and give encouragement throughout this exercise.

#### How to practice:

Have a friend over and ask them if they'd like to groom your dog. Have them softly comb or brush your dog using happy tones to their voice and LOTS of treats.

#### 4. Out for a walk (walking on a loose lead):

This test demonstrates that you are in control of your dog. Your dog may be on either side of you. Your dog's position should leave no doubt that the dog is attentive to you and is responding to your movements and changes of direction. You dog need not be perfectly aligned with your position, as handler and your dog need not sit when you stop. The evaluator may use a pre-plotted course of may direct you and your dog by issuing instructions or commands. In either case, there should be a right turn, left turn, and an about turn with at least one stop in between and another at the end. You may talk to your dog along the way, praise your dog, or give commands in a normal tone of voice. Your may sit the dog at the halts if you desire.

#### How to practice:

Take your dog on daily walks. In the beginning use a Gentle Leader to practice loose leash walking. Be a "tree" if your dog is pulling. Only go forward when the leash is loose. Turning in various directions away from your dog is another way to get your dog to walk nearer to you. Have lots of luscious treats on you and reward your dog for being next to you. A happy tone to your voice will help make the experience even better for your dog.

#### 5. Walking through a crowd:

This test demonstrates that your dog can move about politely in pedestrian traffic and is under control in public places. Your dog and you walk around and pass close to several people (at least three). Your dog may show some interest in the strangers but should continue to walk with you, without evidence of over-exuberance, shyness or resentment. You may talk to your dog and encourage or praise your dog throughout the test. Your dog should not jump on people in the crowd or strain on the leash.

#### How to practice:

Walk your dog in areas that there are people. Keep your dog's attention on you by bringing lots of tasty treats with you to reward your dog staying WITH you. As with #1 - go to stores that allow your dog. Pet stores do, and what a great place to practice walking in a crowd of people with their dogs!

#### 6. Sit and down on command and staying in place:

This test demonstrates that your dog has training, will respond to your commands to sit and down, and will remain in the place commanded by you (sit or down position, whichever you prefer). Your dog must do sit AND down on command, then you choose the position for leaving your dog in the stay. Prior to this test, the dog's leash is replaced with a line 20 feet long. You may take a reasonable amount of time and use more than one command to get the dog to sit and then down. The evaluator must determine if your dog has responded to your commands. You may not force the dog into position but may touch your dog to offer gentle guidance. When instructed by the evaluator, you tell the dog to stay and walk forward the length of the line, turn and return to your dog at a natural pace. Your dog must remain in the place in which it was left (it may change position) until the evaluator instructs you to release your dog. Your dog may be released from the front or from the side.

#### How to practice:

Practice having your dog work on the sit and down commands. Remember to say the word ONCE, and wait. When the dog performs the command – reward! In the beginning you may want to lure your dog into the position with treats. Practice makes perfect. Have your dog sit in front of you then have them sit next to you. Do the same with the down command.

#### 7. Coming when called:

This test demonstrates that your dog will come to you when called. You will walk 10 feet from your dog, turn to face your dog, and call your dog. You may use encouragement to get your dog to come. You may choose to tell your dog to "stay" or "wait" or you may simply walk away, giving no instructions to your dog.

#### How to practice:

While on your walks – be interesting and move in the opposite direction of your dog. Call you dog's name.....as soon as he looks up say "come!" Throw a tasty treat behind you – move again in the opposite direction. Call your dog – throw a treat, and move away. Keep your dog interested in YOU!

#### 8. Reaction to another dog:

This test demonstrates that your dog can behave politely around other dogs. You and another person and your dogs approach each other from a distance of about 20 feet, stop, shake hands, and exchange pleasantries, and continue on for about 10 feet. Neither dog should go to the other dog or its handler.

#### How to practice:

Practice the "watch me" exercise with your dog – especially when there are other dogs and their handlers present. You want to be MORE interesting that the other dog (it IS possible). Bring lots of treats with you (high-end treats) when you go out to practice this exercise. You see another person and their dog approaching – tell your dog to watch you and treat, treat, treat! Now walk on – again when you see that other person and their dog – say, "watch me" and treat! If you aren't having any luck – practice at a distance (20 to 30 feet) and move closer as your dog becomes more in tune to YOU versus the other dog.

#### 9. Reaction to distraction:

This test demonstrates that your dog is confident at all times when faced with common distracting situations. The evaluator will select and present two distractions. Examples of distractions include dropping a chair, rolling a crate dolly past your dog, having a jogger run in front of your dog, or dropping a crutch or cane. Your dog may express natural interest and curiosity and/or may appear slightly startled but should not panic, try to run away, show aggressiveness, or bark. You may talk to your dog and encourage or praise it throughout this exercise.

#### How to practice:

Take your dog walking where there are lots of distractions. At the shopping center, the pet store or hardware store. Walk in the parking lot where you will see lots of cars going by. Take your dog downtown where there may be skateboarders and joggers. Bring your treats. Use your watch me exercise when you and your dog approach the skateboarders or joggers. (Practice for this is very similar to #8 above.)

#### **10. Supervised separation:**

This test demonstrates that your dog can be left with a trusted person, if necessary, and will maintain training and good manners. Evaluators are encouraged to say something like, "Would you like me to watch your dog?" and then take hold of the dog's leash. You will go out of sight for three minutes. Your dog does not have to stay in position but should not continually bark, whine, or pace unnecessarily, or show anything stronger than mild agitation, or nervousness. Evaluators may talk to the dog but should not engage in excessive talking, petting, or management attempts (e.g., "there, there, it's alright").

#### How to practice:

Use your friends or relatives to help you with this exercise. While on a walk, have them hold your dog while you go into a store, or while you walk around the block. Have them sit with your dog in the car while you go into a store, etc. (NEVER TIE YOUR DOG OUT WHILE YOU GO INTO A STORE TO SHOP – ALWAYS LEAVE YOUR DOG WITH A RESPONSIBLE ADULT DURING THIS EXERCISE!)

#### **Veterinary Instructions for Submission**

- 1. The veterinarian or owner must obtain the "Application for Thyroid Database" from the Orthopedic Foundation for Animals, Inc. (phone 573-442-0418), or online at *www.offa.org*.
- 2. The veterinarian and owner must complete their respective portions of the form.
- 3. Two milliliters (2 ml) of serum are needed for testing, and the serum sample must be from freshly collected blood. Use a plain "red-top" tube for blood collection. Do not use a serum separator tube with clot additives or any other type of plasma collection tube. After collection, place the blood sample in the refrigerator for 60 to 90 minutes to allow clotting. Centrifuge, collect the serum, and transfer to a plain plastic or glass tube suitable for shipping. Clearly label the sample with the owner's name, animal's identification, date of blood collection, and "OFA Thyroid Panel." If the specimen is to be stored for more than 12 hours prior to shipping, frozen storage is recommended.
- 4. Ship to the approved laboratory of choice via an overnight courier service. It is recommended that all specimens be packaged properly and shipped so they are received either chilled or frozen. Serum samples arriving unchilled or at room temperature within 48 hours of the collection date will be accepted. However, samples arriving after this time must be received either chilled or frozen in order to be accepted for registry testing. Contact the laboratory for further information as necessary.
- 5. Female dogs should not be tested during an estrus cycle. The date of last routine vaccination should be noted.
- 6. Please do not submit whole blood, clotted blood, or plasma.
- 7. Severely lipemic or hemolyzed specimens are also unacceptable.
- Test results will be mailed or faxed only to the submitting veterinarian and the Orthopedic Foundation for Animals, Inc.. Results will not be available from the laboratory by telephone. The OFA will send a report to the owner.

- a. Free T4 by dialysis (FT4D)—this procedure is considered to be the "gold standard" for assessment of the thyroid's production and cellular availability of thyroxine. FT4D concentration is expected to be decreased in dogs with thyroid dysfunction due to autoimmune thyroiditis.
- b. Canine Thyroid Stimulating Hormone (cTSH)—This procedure helps determine the site of the lesion in cases of hypothyroidism. In autoimmune thyroiditis the lesion is at the level of the thyroid and the pituitary gland functions normally. The cTSH concentration is expected to be abnormally elevated in dogs with thyroid atrophy from autoimmune thyroiditis.
