Incomplete, unsigned, conditional, or received after June 7th 2008 entries will not be accepted. Substitutions are allowed for lame or in-season hounds until time of Roll Call.

Stakes

Field Champion	Any ISWS Field Champion

Conditions of Entry: All entries must be at least one year of age on the day of the trial. Stakes will be split of entry in any one stake is 20 or more at the time of the draw. Bitches in season and lame hounds at Roll Call will be excused and entry fees refunded. Hounds not present at Roll Call will be scratched. Hound certification runs will only be offered as posted on the SilkenFest Agenda. A battery operated Closed Loop Lure Machine will be provided with a Battery operated Drag lure machine as back up. Lure will consist of highly visible plastic. **A \$5.00 per incident fine will be assessed for any hound loose on the field not competing in the course in progress.** All hounds runs at their owners' sole risk.
