- Telegraph, Telephone and Unsigned Entries Cannot Be Accepted. Entries Not On Official ISWS Entry Forms and Photocopies of Entry Forms without Agreement and Rules on the reverse side of the Official ISWS Entry Form are NOT ACCEPTABLE.

- Make All Checks and Money Orders <u>PAYABLE TO JANIS MCMANIGAL</u>. CANADIAN exhibitors must make fees payable in U.S. FUNDS. Please mail checks or money orders with entries. Secretary assumes no responsibility for cash sent through the mail. Tabulate carefully. Due to cost of processing no refunds of \$4.00 and under will be made. There is a \$2.00 fee for any entry cancellations.

No Entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance.

- Entry Fees shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Event Committee. If because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made. Extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, extreme heat, must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry fee will be made.
- Post Dated Checks, Returned Checks and Declined Credit Cards, do not constitute a valid entry fee. The Secretaries will add a \$25.00 collection fee to the amount of each returned check. The returned check or declined credit card MUST BE MADE GOOD by cash or money order BEFORE the dog will be allowed in the ring.
- No Refund for Duplicate Entries. This club and it's Secretary assume no responsibility for the owner or owner's agents entering a dog in a class in which the dog is not eligible to compete, or for entering the same dog twice.
- Errors on Entry Blanks. Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.
- During the hours of judging owners are to be on call, and have their dogs ready for judging. In order that the judging will not be delayed. Dogs need only be present for their judging. Dogs not needed for further judging may be excused. It is the responsibility of the exhibitor to have his dog ready to be shown and at the entrance of the judging ring when the steward calls for the class. Owners of dogs or the handlers of the dogs alone are responsible for the presence of their dogs in the judging rings. It is not the responsibility of the exhibitor to have his dog reserved, nor of any agent of the show giving club to locate any dog, its owner or hander, when the dogs presence is needed in the judging ring. It should be understood by every exhibitor and handler to bring his dog into the ring.
- The club, its secretaries or their employees will not be responsible for the loss of or damage to any dog exhibited, whether the result of accident or other causes and in addition assumes no responsibility for any loss, damage, or injury sustained by an exhibitor or handler. It is distinctly understood that every dog at this show is in the care and custody and control of his owner or handler during the entire time the dog is on the show grounds.
- Cash Prizes will be paid in the ring to the person showing the dog. Claims for prize money must be made in the ring before the judging of that breed is over, and the Secretaries Office advised at once. The Secretaries and show-giving Club disclaim any liability for cash prizes after the judging of the breed is over.
- Trophies and Prizes will be awarded in the judging ring before the completion of judging, any discrepancies must be reported to the Secretary prior to completion of judging. All trophies must be claimed the day of the show. None will be mailed.
- Dogs which according to their owners records have completed the requirements for a championship after the closing of entries for the show but whose championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed or Variety Competition, provided this transfer is made by the Secretary at least one half hour prior to the start of the earliest Conformation judging at the Show.
- Junior Handlers who win a third Novice Class after the closing of entries may transfer their entry from the Novice Class to the Open Class provided that this transfer is made by the Secretary at least one half hour prior to the scheduled start of the earliest Conformation judging or one half hour prior to the start of Junior Showmanship judging at the show, whichever is earlier.
- Please DO NOT LEAVE ANY DOGS IN CLOSED VEHICLES. Do not leave your dogs in unlocked cars. If any dogs are seen to be suffering from extreme temperatures where it is confined without supervision, a California Humane Officer or a Security Officer will be notified to handle the situation. Violators may be reported to the Show Committee for disciplinary action. all persons attending this show hereby waive any claim for damages against the show giving clubs or their members in the event a motor vehicle has to be entered to rescue a dog from overheating or improperly vented conditions. THIS IS A SELF CLEANING SHOW, PLEASE CLEAN UP AFTER YOUR DOGS.
- The show giving club, the show secretary their agents or employees assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, spectators or to their dogs or property. And further assumes no responsibility for injury to any child not under the control of their parents or guardians.

# RV (Recreational Vehicles)/Camping

RV spaces are rented on a first come first serve basis. Triple Crown does not take reservations for RV, and spaces are not guaranteed. RV's must park in the designated RV spaces only. Only one RV is allowed per space. Tent camping is allowed on the East field behind RV parking. RV's and tent campers must pay at the front office or submit payment to the hosting club. Triple Crown will collect the amount from the club via invoice at the end of the event. RV's and campers present after 6:00pm will be charged for one day. Campfires are allowed only in the designated pits and only if there is no county burn ban. Personal barbeque grill use is allowed in the gravel parking area only.

Overnight stays in the Event Center for people or dogs is strictly prohibited. People or dogs found staying in the event center overnight may result in the hosting club forfeiting their deposit.

# Triple Crown Event Center Rules

#### Rental Areas

The area available to you during your event is that which is specified at the time you make your reservation and with this agreement. As there may be multiple events taking place at one time, we ask that clubs please be respectful to not interrupt or interfere with other events. Unauthorized access to Triple Crown kennel areas is strictly prohibited. Unauthorized access to the sports field in front of the office building is prohibited. Triple Crown staff works hard to maintain a clean facility. We appreciate your help in picking up after yourself, as well as your pets.

#### Hours

The Event Center will remain open from 7:00am-8:00pm during your show. Doors will be locked, and lights, ceiling fans, and A/C or heat will be turned off at that time. There is a charge of \$150.00 per hour for the Event Center to remain open after 8:00pm. Advanced notice with approval is required for earlier or later access hours to be granted. Late access charge will be added to your invoice to be paid by the end of your event. Event set up may be scheduled with your event reservation. Set up can take place after 3:00pm the day prior to your event. Normal Triple Crown business may still be conducted on grounds during set up.

#### Parking

Parking is not permitted on adjacent County Road 197. Parking is permitted on gravel lots only, allowing enough room for other traffic as well as emergency vehicles to drive through. If a vehicle is found to be obstructing isles then a representative of Triple Crown will request that the vehicle be moved. If an owner cannot be found, the vehicle may be towed at owner's expense. Parking behind the office building and event center is for loading and unloading only. Loading zones are located on the north and south ends of the office building. No parking is allowed in loading zones. Parking spaces located in front of the club house/office building, as well as in front of the grooming center, are for training and boarding clients only.

It is the Exhibitor's responsibility to contact the hotels/RV Sites/KOAs directly for reservations, pet policies, fees, and restrictions. PLEASE clean up after your dog and be courteous to other hotel guests so that we may use these facilities for future events.

#### Equipment

Triple Crown equipment is not to leave property. All equipment is to be returned by the end of the event. Any damage to equipment which results in a loss to the ISWS will be charged to the person causing the damage. Banners, signs, and logos can be used however; they may not be put up on the walls, doors, or the windows of the Event Center or any other building on Triple Crown grounds. These items are allowed to be hung only from the designated strip on the East end wall.

Duct tape is not to be used on any equipment, tables, chairs, walls, floors, or any object owned and maintained by Triple Crown. Duct tape leaves adhesive behind when it is removed from an object. This can damage some equipment and be very difficult to remove. Only vinyl or painter's tape is allowed.

Outside Food and Beverages are not to be sold by any unauthorized person(s), group, or business. Outside food and beverage are not allowed in the clubhouse. Sale of outside food and beverages must first be approved by Event Manager. Concessions are the responsibility of the hosting club to arrange. Clubs may not prepare and sell food during an Event. Catered meals or sack lunches may be brought in for an Event.

#### Dogs

Dogs must be kept on leash with the leash in the hands of the handler when outside the Event area for the safety of all dogs visiting Triple Crown. Dogs and puppies may not be sold on premises at Triple Crown without exception. People found selling dogs on grounds will be asked to leave. (Established rescue groups and humane societies are welcome to bring pets available for adoption at hosting clubs' discretion.)

Exercise and Potty Areas for events are located on the North side of the Arena and are clearly marked. The courtyard and patio area in front of the Event Center is not a potty area. Please keep pets out of landscaping.

Please pick up after your pets. The sports field in front of the office building is not an exercise or potty area. Unauthorized access to this area is prohibited. To help prevent damage, please do not groom dogs in front of marked A/C exhausts.

As Triple Crown is a fully functional training and boarding facility, we ask that all event participants act as responsible pet owners and maintain current vaccinations on all pets on Triple Crown grounds.

Signs have been put up around the grounds to help keep all people and dogs safe as well as to aid in maintaining the grounds. The hosting club must take measures to ensure that all participants follow the directions that are posted on these signs.

Motorized vehicles are not allowed to be driven inside the Event Center without exception.

Smoking is prohibited in the Event Center or any other buildings located on the Academy grounds. Please use the cigarette butt containers located in front of the Event Center and in locations around the Pro Shop/Clubhouse building.

#### NON-REGULAR CLASSES, INVOLVING SINGLE DOG ENTRIES

ISWS Champions of Record, Winners Dog, Winners Bitch and Best Veteran Only will be allowed to compete for Best of Breed

#### NON-REGULAR CLASSES, INVOLVING SINGLE DOG ENTRIES

#### Companion Dogs Companion Bitches

This class is open to any dog or bitch that is 6 months or older at the time of this show. Dogs and bitches will compete separately and winners will not be eligible for Best of Breed judging.

Companion Class are not eligible to compete for Championship points nor are they to be counted toward points awarded and winners are not eligible to compete for Best of Breed. Ribbons will be awarded 1st through 4th place. Winners of the Companion Class will compete for Best Companion.

#### NON-REGULAR CLASSES INVOLVING MULTIPLE DOG ENTRIES

As the judge's decision in the following classes is based on the merits of more than one dog or bitch, no one of the dogs or bitches judged first in these classes will be eligible to compete for Best of Breed by virtue of having won in these classes. The Stud Dog or Brood Bitch must appear in the ring with the get or produce and be entered in the class. The owner of the Stud Dog or Brood Bitch does not need to be the owner of the get or produce. The award is based on the merits of the get or produce.

Stud Dog Class: For dogs that have sired two dogs or bitches entered in this show.

Brood Bitch Class: For bitches that have whelped two dogs or bitches entered in this show.

#### SPECIAL AWARDS

Awards of Merit: There will be five (5) Awards of Merit available, which the judge may award at his discretion immediately after the selection of Best of Breed, Best of Winners, and Best of Opposite Sex.

Best In Puppy Class: Best Puppy will be selected from the Regular Puppy Class winners following the judging of Best of Breed competition. Only dogs not defeated in a Puppy Class are eligible to compete. (If the winner of a class is not present for judging of the Best Puppy, the 2nd place in the class may not take its place). If Best of Winners or Best of Breed is from the Puppy Class it is automatically the Best Puppy in Classes.

Best in Companion Class: Best Companion will be selected from the Companion Class winner following Best of Breed competition

Best Bred By Exhibitor: Best Bred By Exhibitor will be selected from the Bred By Exhibitor Class winners following Best of Breed competition.

#### JUNIOR SHOWMANSHIP CLASSIFICATION

Novice Junior Class: For boys and girls who are at least 9 years old and under 12 years old on the day of the show and who, at the time entries close, have not won three first place awards with competition present in a Novice Class at a licensed or member show.

Open Junior Class: For boys and girls who are at least 9 years old and under 12 years old on the day of the show and who, at the time entries close have not won three first place awards with competition present in a Novice Class at a licensed or member show.

Novice Intermediate Class: For boys and girls who are at least 12 years old and under 15 years old on the day of the show and who, at the time entries close, have not won three first place awards with competition present in a Novice Class at a licensed or member show.

Open Intermediate Class: For boys and girls who are at least 12 years old and under 15 years old on the day of the show who, at the time entries close, have won three first place awards with competition present in a Novice Class at a licensed or member show.

Novice Senior Class: For boys and girls who are at least 15 years old and under 18 years old on the day of the show and who, at the time entries close, have won three first place awards with competition present in a Novice Class at a licensed or member show.

Open Senior Class: For boys and girls who are at least 15 years old and under 18 years old on the day of the show and who, at the time entries close, have won three first place awards with competition present in a Novice Class at a licensed or member show.

No entry may be changed or cancelled unless notice of the change or cancellation is received in writing by the Show Secretary named in the premium list to receive entries, prior to the closing date and hour for entries, except that a correction may be made from one age division to another provided this transfer is made by the Show Secretary at least one half-hour prior to the scheduled start of any Junior Showmanship Class at this show.

Best Junior Handler: A club offering Junior Showmanship may offer a prize for Best Junior Handler, provided there will be competition for this award, a minimum of two class winners present to compete for the award. The prize is described in the premium list. The Junior Handler placed first in each of the regular Junior Showmanship Classes, if undefeated in any other Junior Showmanship Class at that show, shall automatically be eligible to compete for this prize.
