

- · Bitches in season, lame hounds, and hounds with breed disqualifications will be excused at roll call
- · Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered..
- · Hounds not present at the time of roll call will be scratched.
- \cdot Hound certification runs will NOT be offered on the day of the trial.
- · A battery powered continuous loop lure machine will be used; backup equipment will be available.
- · Lure will consist of highly visible plastic.
- There will be a \$5.00 fine for any loose hounds on the field which are not in the course in process.
- · The club reserves the right to alter the course as required by weather and/or field condition on the day of the trial.
- \cdot Courses will be reversed for finals and again for BOB.
