#### FIRST CLASS MAIL DATED MATERIAL

**General Site Description:** The Sells Station Road soccer complex is fenced and remote from busy roads. The weather may be hot, and field conditions vary from dry through wet and muddy. **Please** provide shade and water for your hounds.

**Directions:** From Host Hotel (Gettysburg) - Head southwest on US-15 BUS S/Emmitsburg Rd toward Cunningham Rd. Merge left onto US-15 N toward Harrisburg. Take the PA-97 exit toward Baltimore St and turn right onto PA-97 N/ Baltimore Pike. Turn sharp left onto White Hall Rd and then take a slight right onto Littlestown Rd in just under a mile. Turn right onto Sells Station Rd and the field will be on the left.

From West or South - Take Rt. 97 to Littlestown. At the traffic light take Rt. 194 N to Sells Station Rd. Turn left onto Sells Station; 1.3 miles to site.

From East or North - Take Rt. 194 S out of Hanover. Sells Station Rd is 0.8 miles past the main entrance to Hanover Shoe Farms. Turn right on Sells Station Rd; 1.3 miles to site.

### **ELIGIBILITY REQUIREMENTS:**

Only purebred Silken Windhounds individually registered with the United Kennel Club (UKC) and/or International Silken Windhound Society (ISWS) may be entered.

Late, incomplete, unsigned or unpaid entries will not be accepted. Entries will not be acknowledged by mail or phone. Substitutes for lame or in-season hounds will be allowed if substitute has the same owner and field secretary is notified before close of entries.

All first time entries MUST include a copy of the hound's registration certificate. The entry for each hound entering the Limited Stake for the first time MUST include a completed & signed ASFA Certification Form or Waiver Form (with proof of title) and a copy of the hound's registration certificate (ASFA certification waived for Single Stake entries only).

### **STAKES OFFERED:**

**Provisional Open Stake:** Any eligible Silken Windhound, excluding ASFA Field Champions of record. **Provisional Field Champion Stake:** Any ASFA Field Champion of record. **Provisional Veteran Stake:** Any eligible Silken Windhound whose age is at least six years. Points go toward V-FCh or V-LCM titles. **Singles:** Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. **Kennel Stake:** An entry shall consist of two Silken Windhounds, designated at time of entry, in one of the regular stakes being owned and kenneled by the same person. **ISWS Conformation (Bench) Stake:** An entry shall consist of a single hound with proof on file with the ISWS of a conformation championship. **Best in Field** will not be offered.

### **CONDITIONS OF ENTRY:**

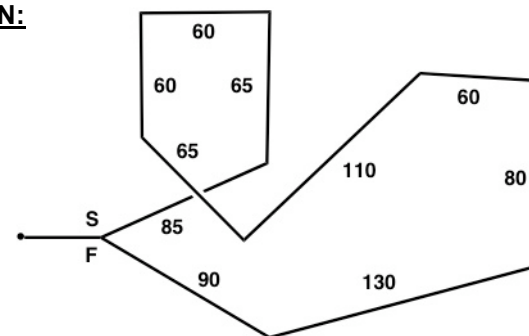
- All entries must be one year or older on the day of the trial.
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered. Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
- Hounds not present at time of roll call will be scratched.
- All hounds will run twice, in trios if possible, or braces (except in the Single Stake), unless excused, dismissed or disqualified.
- There will be certification runs on the day of trial as time permits.
- A \$5.00 penalty will be collected for any loose hound not in competition.
- **Persons exhibiting unsportsmanlike conduct detrimental to ASFA, this club, any hound or person will be asked to leave the trial site.**

### **EQUIPMENT:**

A battery powered, continuous loop system will be used with white or colored plastic streamers and/or fur for the lure. Back-up equipment will be available.

### **COURSE PLAN:**

805 yards



The club reserves the right to alter the course plan as required by weather and/or field conditions on the day of the Trial. Course will be reversed for finals and runoffs.
