Directions: From East (including Battle Creek/ host hotels) - Head west on I-94 W toward Chicago. Take exit 81 to merge onto I-94 BUS W toward Downtown/Kalamazoo. Turn right onto Olmstead Road after 1.2 miles. Take the first left onto Lake Street and the event center will be on the left.

From West – Head east on I-94 E. Take exit 80 for Sprinkle Road toward Cork Street and turn left onto S. Sprinkle Road. Turn left onto I-94 BUS W and then the first right onto Olmstead Road. Take the first left onto Lake Street and the event center will be on the left.

From North – Head South on US-131 S. Take the US-131 exit on the left toward 3 Rivers. Merge onto US-131 BUS S. After 4.7 miles, turn left onto W Paterson Street. Turn right onto Riverview Drive and continue onto E Michigan Avenue. Turn left onto I-94 BUS E/M-96 E. Keep right to continue on I-94 BUS E (I-96 goes straight). ELIGIBILITY REQUIREMENTS:

Only purebred Silken Windhounds individually registered with the United Kennel Club (UKC) and/or International Silken Windhound Society (ISWS) may be entered.

Late, incomplete, unsigned or unpaid entries will not be accepted. Entries will not be acknowledged by mail or phone. Substitutes for lame or in-season hounds will be allowed if substitute has the same owner and field secretary is notified before close of entries.

All first time entries MUST include a copy of the hound's registration certificate. The entry for each hound entering the Limited Stake for the first time MUST include a completed & signed ASFA Certification Form or Waiver Form (with proof of title) and a copy of the hound's registration certificate (ASFA certification waived for Single Stake entries only).

STAKES OFFERED:

Open Stake: Any eligible Silken Windhound, excluding ASFA Field Champions of record. **Field Champion Stake:** Any ASFA Silken Windhound Field Champion of record. **Veteran Stake:** Any eligible Silken Windhound whose age is at least six years. Points go toward V-FCh or V-LCM titles. **Singles:** Any eligible Silken Windhound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. **Kennel Stake:** An entry shall consist of two Silken Windhounds, designated at time of entry, in one of the regular stakes being owned and kenneled by the same person. **ISWS Conformation (Bench) Stake:** An entry shall consist of a single hound, in one of the regular stakes, with proof on file with the ISWS of a conformation championship. **Best in Field** will not be offered.

CONDITIONS OF ENTRY:

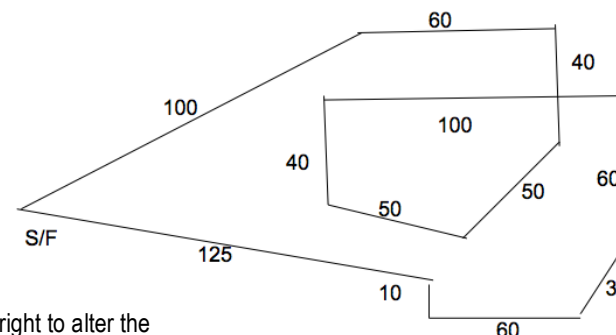
- All entries must be one year or older on the day of the trial.
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered. Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
- Hounds not present at time of roll call will be scratched.
- All hounds will run twice, in trios if possible, or braces (except in the Single Stake), unless excused, dismissed or disqualified.
- There will not be an opportunity for certification runs on the day of trial.
- A \$5.00 penalty will be collected for any loose hound not in competition.
- **Persons exhibiting unsportsmanlike conduct detrimental to ASFA, this club, any hound or person will be asked to leave the trial site.**

EQUIPMENT:

A battery powered, continuous loop system will be used with white or colored plastic streamers and/or fur for the lure. Back-up equipment will be available.

COURSE PLAN:

735 yards



The club reserves the right to alter the course plan as required by weather and/or field conditions on the day of the Trial. Course will be reversed for finals and runoffs.
