Directions: From East (including Battle Creek/ host hotels) - Head west on I-94 W toward Chicago. Take exit 81 to merge onto I-94 BUS W toward Downtown/Kalamazoo. Turn right onto Olmstead Road after 1.2 miles. Take the first left onto Lake Street and the event center will be on the left.

From West - Head east on I-94 E. Take exit 80 for Sprinkle Road toward Cork Street and turn left onto S. Sprinkle Road. Turn left onto I-94 BUS W and then the first right onto Olmstead Road. Take the first left onto Lake Street and the event center will be on the left.

From North - Head South on US-131 S. Take the US-131 exit on the left toward 3 Rivers. Merge onto US-131 BUS S. After 4.7 miles, turn left onto W Paterson Street. Turn right onto Riverview Drive and continue onto E Michigan Avenue. Turn left onto I-94 BUS E/M-96 E. Keep right to continue on I-94 BUS E (I-96 goes straight). Turn left onto Lake Street and event center will be on the right.

ELIGIBILITY REQUIREMENTS:

Only purebred Silken Windhounds may be entered. All Silken Windhounds must be one (1) year of age or older on the day of the official race meet to be entered. All entries shall be individually registered with the United Kennel Club (UKC) and Large Gazehound Racing Association (LGRA).

Silken Windhounds qualified for ISWS Oval Racing meets are considered already qualified for LGRA. The person entering a Silken Windhound for racing must be the actual owner, or agent of the owner, or be in possession of papers transferring said ownership to person entering the Silken Windhound.

Spayed/neutered Silken Windhounds may compete.

**ALL FIRST TIME ENTERED MAY BE REQUIRED TO HAVE A QUALIFYING RUN
WITH ANOTHER SILKEN WINDHOUND BEFORE THE RACE MEET.**

Incomplete, unsigned, late or unpaid entries will not be accepted.

Entry fees will be forfeit if a Silken Windhound is not present at Roll Call. Entry fees shall be forfeited if a Silken Windhound is disqualified, dismissed or scratched from racing for cause except the following: 1) Bitches in season, which come in after entry is made, shall have their fees refunded; and 2) Silken Windhound which are determined to be lame, obviously sick, or in season by the Inspection Committee prior to completing any races shall be barred from racing and have their entry fees refunded. Substitutes for lame or in-season hounds will only be allowed if substitute has the same owner and race secretary is notified before close of entries.

All hounds entered must be registered with LGRA. Registration is accomplished by sending a copy of the individual UKC registration papers (previously described) with a fee of \$2.00 U.S. at least two weeks prior to the race meet to: LGRA, Dawn Hall, LGRA Registrar-Recorder, 900 S. East St., Weeping Water, NE 68463-4430, (402) 210-2125 - newfs4me@gmail.com. The dog may be registered with entries by submitting the above requirements to the Race Meet Secretary. LGRA registration is for the life of the dog.

ALL RACERS MUST WEAR RACING MUZZLES!

Racers must wear their muzzles from the paddock area to the start.

Muzzles may be either Greyhound racing muzzles, plastic-coated English racing muzzles or plastic Greyhound turnout muzzles. Muzzles made of heavy wire are dangerous and are NOT PERMITTED. Light wire muzzles of the English type if not plastic coated, are NOT PERMITTED. A few racing muzzles and racing jackets will be available for use. Muzzles provided may not fit all Silken Windhounds. To insure proper fit of muzzles, please bring your own.

All First Time Entered (FTE) starters will start as Grade D racers.

Racing jackets are: white #1 on Red blanket, white #2 on Blue blanket, black #3 on White blanket, white #4 on Green blanket.

A \$10.00 fine will be assessed for any dog loose on the field which interferes with the running of a race.

RISK & RESPONSIBILITY:

The owner or agent entering a Silken Windhound in a LGRA meet assumes all risk and responsibility for loss or injury suffered or caused by his/her Silken Windhound while on the grounds or near the entrance of the race meet. Owners/ Handlers at LGRA events accept and agree to abide by the rules, and generally accepted rules of conduct of good sportsmanship. Further, they shall pick up after their dog, keep the grounds clean, and treat their hounds with respect and in a humane manner.
