### ELIGIBLE BREEDS & REGISTRIES:

Only purebred Silken Windhounds individually registered with the United Kennel Club (UKC) and/or the International Silken Windhound Society (ISWS) may be entered.

### STAKES OFFERED

**SINGLE:** Any eligible Silken Windhound including those disqualified to run in other stakes. Hounds are eligible to earn TCP & CPX titles from the Singles Stake. Hounds will run alone. Not eligible for BOB.

**OPEN:** Any eligible Silken Windhound excluding A.S.F.A. Field Champions of Record that has met certification requirements.

**FIELD CHAMPION:** Any A.S.F.A. Field Champion.

**VETERAN:** Eligible hounds over 6 years of age that have met certification requirements.

**KENNEL:** An entry shall consist of 2 Silken Windhounds, designated at the time of entry, In one of the regular stakes being owned and kenneled by the same person.  
**ISWS CONFORMATION (BENCH) STAKE:** An entry shall consist of a single hound with proof on file with the ISWS of a conformation championship.

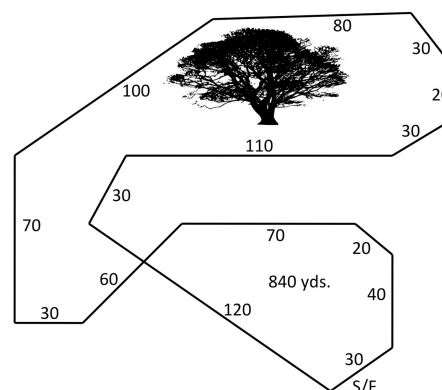
**FIRST TIME ENTERED HOUNDS MUST SUBMIT A COPY OF THEIR  
REGISTRATION WITH THEIR ENTRY FORMS !**

**As of October 1, 1994, ASFA requires that all dogs being entered in the Open, or Veteran Stake for the first time submit a Certification Form with their entry**

**CONDITIONS OF ENTRY:** All entries must be 1 year of age or older on the day of the Trial. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more. Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered. Hounds with breed disqualifications are not eligible to enter except the Single Stake. Hounds not present at the time of roll call will be scratched. All hounds will run twice, in trios if possible or braces (except in the Single Stake) unless excused, dismissed or disqualified. Muzzles will not be required but may be used at the handlers discretion. A \$5.00 fine will be imposed for any loose hound on the field not competing in the course in progress. Club reserves the right to alter the course the day of the trial due to weather and/or field conditions. Owners must keep hounds under control and clean up after them. The course will be reversed for final courses, reversed again for Best of Breed, and Run-Offs. Certification runs will be offered after the trial.
