AGREEMENT

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to compete for prizes, ribbons or trophies, I/we agree to hold ISWS, ASFA and LGRA, their respective members, directors, governors, officers, agents, superintendents, event secretaries, and committee members, as well as the owner/lessee of the premises and any providers of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, including but not limited to judges, secretaries, and stewards, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I/we personally assume all responsibility and liability for any such claim;

I/we further agree to hold all the aforementioned parties in this agreement harmless from any claim for loss, injury or damage to this dog;

I/we hereby assume the sole responsibility for and agree to indemnify, defend, and save all the aforementioned parties harmless from all loss and expense (including all legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death, at any times resulting there from, sustained by any person or persons, including myself/ourselves or on account of damage to property, arising out of, or as a consequence of, my/our participation in this event, however such injuries, death or property damage may be caused, and whether or not to the same parties or any of their employees, agents, or any other persons.

I/we agree that any cause of action, controversy, or claim arising out of or related to the entry, exhibition or attendance at the event between ISWS, ASFA or LGRA or any committee member, volunteer, sponsor, etc., the owner of the event premises, and myself/ourselves or as to the construction, interpretation and effect of this agreement shall be governed by Texas law.

I/we also agree to be held responsible for any and all damage, caused by either myself/ourselves or the dogs in our care, whether owned or acting as agent, done to the property.
