### ELIGIBILITY REQUIREMENTS:

Only purebred Silken Windhounds individually registered with the United Kennel Club (UKC) and/or International Silken Windhound Society (ISWS) may be entered.

Changes of stake and substitutions for lame or in season hounds may be made by notifying the Field Trial Secretary. Substitutions must be made no later than close of entries. Substitutions must be from the same owner & household only. Entries will **NOT** be acknowledged by mail.

**Incomplete, unsigned, conditional or unpaid entries will not be accepted**

All first time entries MUST include a copy of the hound's registration certificate. The entry for each hound entering the Open or Veteran Stake for the first time MUST include a completed & signed ASFA Certification Form or Waiver Form (with proof of title) and a copy of the hound's registration certificate (ASFA certification waived for Single Stake entries only).

### STAKES OFFERED:

**Open Stake:** Any Silken Windhound excluding ASFA Field Champions of record, that has met the certification requirements.

**Field Champion Stake:** Any ASFA Field Champion\* of record.

**Veteran Stake:** Any eligible hound\*, whose age is at least six years that has met the certification requirements. Points go toward V-FCh or V-LCM titles.

**Single Stake:** Any eligible Silken Windhound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Provisional breeds are not eligible for these titles.

**Best in Field** will be offered.

### AWARDS:

BOB: ASFA BOB Plaque, Purple & Gold Rosette and Prize, High Scoring Singles: Navy & Gold Rosette and Prize, First: Blue Rosette and Prize, Second: Red Rosette, Third: Yellow Rosette, Fourth: White Rosette, NBQ: Dark Green Rosette

Nonstandard stakes: High Scoring Kennel Stakes: Teal & Purple Rosette, ISWS Conformation (Bench) Stakes: Purple & Gold Rosette.

### CONDITIONS OF ENTRY:

- All entries must be one year or older on the day of the trial.
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered.
- Hounds with breed disqualifications are not eligible to enter, except in the Single stake.
- Hounds not present at time of roll call will be scratched.
- All hounds will run twice, in trios if possible, or braces, unless excused, dismissed or disqualified. Except in Single stake.
- Certification runs will be offered **\*after\*** the trial, pending condition of the equipment, time and weather. **Certifications will be by pre-entry only.** Be sure to arrange your own by-dog.
- A \$5.00 penalty will be collected for any loose hound not in competition.
- **Persons exhibiting unsportsmanlike conduct detrimental to ASFA, this club, any hound or person will be asked to leave the trial site.**

### EQUIPMENT:

Battery powered, DRAG lure machines with backup equipment available. The lure will consist of highly visible white plastic strips.

### GENERAL INFORMATION:

- Please bring your own food, shade and water.

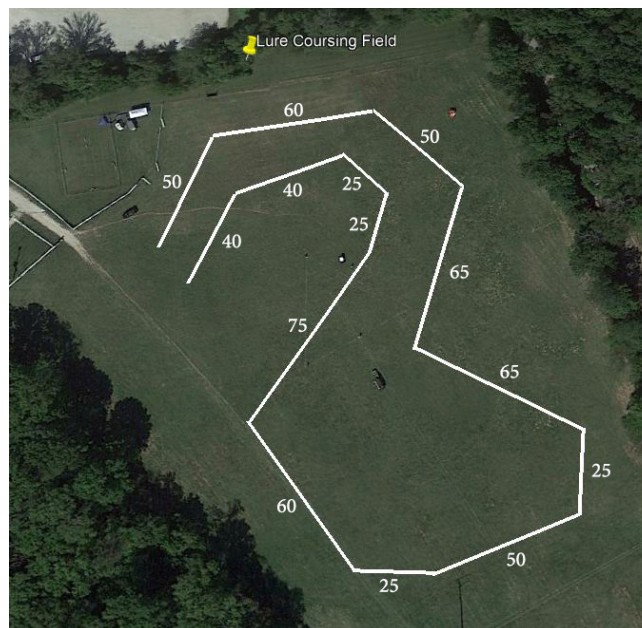
