ISWS HOLTER RULES

The ISWS Holter monitor and accessories are available to individual Silken Windhound owners, and Silken Windhound clubs or groups.

For all rentals a Holter Rental Agreement must be on file with Ashley Cirimeli. Once a Holter Rental Agreement and the Sign Out Form is on file, your name will enter the queue. Once a Holter is ready for you, Ashley will email you to submit payment and move forward with shipping.

For individual rentals, once the Holter Rental Agreement is received and approved, the cost of rental must be paid through paypal or check to ISWS Health and Rescue (ISWSHealthRescue@gmail.com). Once payment has been verified, the equipment will be shipped to the individual according to the holter rental schedule. Holter Rental Costs payable to the ISWS covers consumables, normal wear and tear, and purchase of future improvements/supplies.

Holter rental with shared results, including heart health updates - first dog	\$40	Rental of Holter package includes shipping to the borrower
Additional dogs with shared results-same mail out, same owner	\$30	Rental of Holter package for each additional dog with the same owner, with one mail out.

All equipment must be returned to Ashley Cirimeli.

Silken Windhound Clubs and Groups may act as Agents on behalf of the ISWS in administering Holter use to club members. Agents are expected to make every effort to keep the equipment in good condition, promote proper use and care, and notify Ashley Cirimeli if there are any issues, problems, or breakage.

By renting an ISWS holter, you are agreeing to share the results with two people: Danielle Snyder Steenkamp DVM, and the cardiologist researching Silken Windhounds.

Information will only be shared in the form of aggregated data, with names/identifiers redacted. More information can be found on the Information Release Form.

With your help, this shared data will aid us in understanding the types of arrhythmias found in Silken Windhounds and what impact these arrhythmias have on the well being of the dog. **Failure to submit results** within 4 weeks of receipt will result in a ban from future rentals.

Recording: Unless otherwise specified by your cardiologist, the recording period for each dog is 24 hours. The dog can and should participate in most normal activities EXCLUDING WATER.

We ask that you do not participate in any water sports/activities with your dog, or be outside in the rain. Please be mindful of crates and dog doors, which can bump/shift the equipment.

Rental Period: Rental periods are for up to 1 week for 1-5 dogs. However, if this period of time will not be sufficient for you to conduct the test, clean and air dry the vest, and then ship the equipment, you must ask for a longer period BEFORE the rental agreement is finalized. Equipment arriving late will be assessed a late fee of \$10 per day.

Results: Holter reading is available (results only) through Alba Medical Inc. <u>Always request the</u> **FULL DISCLOSURE** report when submitting results.

Alba Medical, Inc. offers interpretation of the results by a cardiologist for an additional fee. The cardiologist working with Silken Windhounds can also interpret the results, which is less expensive than the Alba Medical Inc cardiologist. If you would like to go this route, please include the request when you send your results to Dr. Danielle Snyder Steenkamp. You are responsible for sending the data to whomever you have chosen to read the results.

Cleaning the Vest: The vest is to be washed and AIR dried prior to return. NEVER dry the vest in a dryer. Wash on gentle cycle with a mild detergent. AIR dry. LINT ROLL the vest to remove hair. Equipment returned dirty will be assessed a cleaning fee of \$25.

It is important to note that wires and the leads are NOT disposable.

If any of your animals were ill while utilizing the rental, or become ill at any point surrounding the rental period, Ashley Cirimeli must be notified. Borrower is responsible for costs incurred for disinfecting or replacing the equipment.

Damages: Any loss or damage to the equipment is the borrower's responsibility. It is recommended that the dog be monitored closely, at all times during the rental period. Muzzles, Elizabethan collars, and crates can be utilized if you expect or find your dog trying to chew the equipment, especially during times in which they cannot be monitored.

You will need to shave behind the elbows on both sides of your dog in order to accommodate the electrodes. This isn't mandatory, but is recommended to ensure a better connection.

Return Shipping: Borrower is responsible for return shipping/handling costs. Please ship through USPS. It is highly recommended to purchase insurance on the shipment, as Borrower is responsible for any damages or loss. Return shipping address will be provided via email.
