ISWS Conformation Classes

(AKA what class do I enter my dog in?)

There are different kinds of classes in every ISWS Specialty show. There are Regular and Non-regular classes, Altered classes, and Junior Handler and Showmanship. All approved shows must offer the Regular Classes. Some classes are "optional" and every sponsoring club decides which of these Optional Classes they also wish to offer. All of the regular classes are available for both dogs and bitches. Dogs are judged first, followed by bitches, preceded or followed by various non-Regular classes.

Below are descriptions of all of the classes. Use them to determine where you wish to enter your dog(s).

Regular Classes for Dogs and Bitches

In all puppy and the 12-18 months class the age of the puppy is determined on the day of the show, not the date of entry or registration.

6-9 Month Puppy - For puppies that are at least 6 but less than 9 months old on the date of the show.

9-12 Month Puppy - For puppies that are at least 9 but less than 12 months old on the date of the show.

First place in each of these puppy classes will compete for Best Puppy in Show.

12-18 Month - For dogs at least 12 months of age and less than 18 months old that are not ISWS Champions.

Novice - For dogs at least 6 months old who have not, at the close of entries, won 3 first place prizes in the Novice class, nor a first place in the Bred By Exhibitor or Open classes, nor 3 points toward their ISWS championship.

Bred By Exhibitor - The Bred By Exhibitor class has the following requirements:

- Six months of age or older on the date of the show
- Not a champion of record in ISWS on the date of the show
- Must be Owned or co-owned by any of the breeders of record on the date of the show
- Handler must be a breeder of record and an owner/co-owner of the entered dog. In any subsequent classes for which the dog becomes eligible there are no handler restrictions.

American Bred - For all dogs, except ISWS champions, who are 6 months of age or over, that were whelped in the US, by reason of a mating that occurred in the US.

Field Performance - For all dogs, except ISWS champions that have earned a performance championship for straight racing, oval racing, lure coursing or open field coursing..

Open - For any dogs 6 months of age or older.

Winners - Winners is not a class you enter. The right to go in to the Winners class is earned by having won a regular class. Following the judging of the Regular Classes each class winner will be called to the ring to compete for Winner's Dog. After Winners is awarded, the dog/bitch that was second in the same class from which the Winner came will be called to the ring to compete for Reserve Winners. The Winners Dog and Winners bitch will compete for Best of Winners and Best of Breed. Both Winners Dog and Winners Bitch receive points toward their ISWS championship.

Best of Breed - For all ISWS Champions of record, plus Winners Dog, Winners Bitch, Best Veteran dog, and Best Veteran Bitch.

Non-Regular Classes for Dogs and/or Bitches

3-6 Month Puppy - For puppies at least 3 but less than 6 months on the date of the show.

Altered Open - For all altered dogs (except ISWS or Altered ISWS champions) 6 months of age or over.

Altered Winners Class – NOTE: This is not a class you enter. The right to go in to the Winners class is earned by having won an Altered class. Following the judging of the Altered Classes each class winner will be called to the ring to compete for Best Altered. After Best Altered is awarded, the dog of the opposite sex to the Best Altered will be awarded Best of Opposite Sex Altered.

Best Altered — The following are eligible to participate in this competition:

- a) Altered ISWS Champions;
- b) Altered Winners Dog and Altered Winners Bitch

Veterans- For all dogs/bitches 7 years of age and over. Classes are often divided in to 7-10 years, and 10 years and over. Both Veteran Dog and Veteran Bitch winners will compete in Best of Breed. These dogs will not receive any ISWS championship points.

Stud Dog /**Brood Bitch** - The Stud Dog or Brood Bitch, along with at least 2 of their get, appear in the ring together. The stud dog or brood bitch must be shown in the ring with its get, although they do not have to be entered in the show. Their get must be entered in another class in the show to be eligible. Stud dog and brood bitch may be altered. The class is judged on the quality of the get. There are no common owners required.

Brace - A Brace is defined as two dogs that are similar in appearance, performing in unison and presented by a handler whose name is on both dogs as either an owner or co-owner. Both dogs do not need be to be intact, nor the same sex, nor entered in any other class at the show. They are judged 40% on conformation, 40% on matching looks, and 20% on difficulty of the match.

Junior Handler and Showmanship - These classes are for children aged 2 -18. Junior Handlers are divided into 2-4 and 4-8 years of age, Junior Showmanship is for children ages 8-18, divided into 8-12 and 12-18. Junior Handlers must be accompanied/assisted in the ring by an adult. Any Junior may show any dog entered in any class, regular or non-regular, altered or in-tact, that is entered in the show.

NWFest's 7th annual Oregon Trail Award

Crossing the continent to Oregon took a great emotional and physical strength. Pioneers had to have great endurance and a wide range of skills to survive. The hound winning the Oregon Trail Award must demonstrate speed, agility, endurance, and focus. By placing well in conformation, the hound also reflects the beauty of this great region.

This award is for those hounds that compete in one or both ISWS specialties and feel they still have more to give. In order to be eligible to compete for the award of the Oregon Trail Hound, you must enter and compete in a special conformation class to be held after the second ISWS Specialty show as well as the LGRA straight racing meet and the ASFA lure coursing trial.

Any hound may be entered in any event or combination of events, but only hounds that compete in all three areas of competition will be eligible to become Oregon Trail Hound. To be eligible, hounds must complete all three events, without dismissal or disqualification. Hounds scratched from any event, for any reason, are ineligible for Oregon Trail Hound awards.

LGRA entries will be ranked in order of its placement relative to the other hounds competing for the award. Each hound is ranked in order of finish.

In ASFA Lure Coursing, once again entries will be ranked in order of placements relative to the other hounds competing for the award. For placement the preliminary and final scores will be added together for the dog's total score, regardless of stakes. For tied scores, if those dogs happen to compete in a run off, the winner will receive the lower score. Otherwise the ranks will be averaged (if a dog in Open and FCH stakes were tied for rank 3 with 291 points; rank 3+4/2=3.5 points for each. BOB will receive extra 10 points added to their final score before placement.

For the tied scores, the 7 and 8 ranks are averaged at 7.5.

Any Ties: If 2 hounds are tied the hound with the lowest single ranking would win. If still tied (i.e. both had a BOB), then the dog with the 2 lowest rankings would win. (Ranks 1+2+4+6 wins over 1+3+3+6)

Each entrant's ranks from the three events will be summed. The hound with the LOWEST score will become the first Oregon Trail Hound. For example, a perfect score, earned by the highest ranked dog in each event, would be a 4.

The Oregon Trail Award is being sponsored by J Vookles of InPhenite Sighthounds.

No entry fees will be refunded, in the event a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of any member of the Sanders/Allagante, the Show or Trial Secretary, or any member of SWEPT. No entry fees will be returned if the show cannot open or be completed by reasons beyond the control of the management. Extreme weather conditions, such as, but not limited to, snow storms, hurricanes, lightning, extreme heat or cold, must be considered for the health and safety of the dogs, exhibitors and spectators. The wellbeing of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry fees will be made.
